### Three Indicted in Connection to July Stoughton Murder

Two arraigned this afternoon in Norfolk Superior at 2 p.m

A Norfolk County Grand Jury yesterday indicted a Stoughton 17-year-old for murder in the July 21, 2020, fatal shooting of 17-year-old Christian Vines in the town of Stoughton and indicted two adults for accessory after the fact of that murder, according to Norfolk District Attorney Michael W. Morrissey.

"The superior court murder arraignment of Jaylen Wallace has not yet been scheduled, but we expect the arraignment of the man and woman indicted as accessories this afternoon in Norfolk Superior Court at 2 p.m.," District Attorney Morrissey said.

Indictment warrants issued yesterday for Ms. Alyssa Joyette, 19, of Brockton, and Mr. Tyleke Curry, 22, of Stoughton. They were taken into custody today (October 23, 2020) by Stoughton and State Police at a Stoughton residence. Neither had been charged previously in the case.

"They are being processed at the Stoughton Police Department and will be transported to Superior Court in Dedham in advance of this afternoon's arraignment. I have assigned the prosecution of all three defendants to Assistant District Attorney Jennifer Blair," District Attorney Morrissey said. "Stoughton Police continue to be excellent partners with our State Police detectives and our prosecutors in this case."

The incident remains under active investigation with additional indictments anticipated.

#### ARRAIGNMENT UPDATE:

Both defendants entered not guilty pleas at their Superior Court arraignments this afternoon.

Assistant District Attorney Jennifer Blair requested \$75,000 cash bail on each defendant. The Court imposed \$2,500 cash bail on Mr. Curry with conditions that he be fitted with a GPS monitoring device, and stay away from and have no contact with the victim's family or Ms. Joyette should he post bail. Ms. Joyette was released on her personal recognizance with orders to stay away from and have no contact with the victim's family or Mr. Curry. Both defendants must abide by a 7 p.m. to 7 a.m. curfew. They are due back in Norfolk Superior Court Jan. 20, 2021 for pre-trial conference.

No superior court arraignment date has yet been set for Mr. Wallace. He remains in custody.

*All defendants are presumed innocent until proven guilty beyond a reasonable doubt.*
