### Guns, Drugs seized in related Randolph and Fitchburg searches

Following an extensive investigation into the trafficking and distribution of narcotics, State Police Detectives assigned to Norfolk District Attorney Michael W. Morrissey's Office obtained search warrants for two locations in Randolph and a third in the City of Fitchburg that were simultaneously executed at approximately 5:30 a.m. today, December 22, 2020.

As a result of these warranted searches, authorities seized two hand guns, one having an obliterated serial number, more than 450 grams of cocaine, more than 175 grams of Fentanyl, approximately 10 pounds of marijuana, and approximately \$42,000 in United States currency, according to District Attorney Morrissey.

The locations in Randolph were at 12 Crawford Street and 8 Sunset Drive. The Fitchburg location was 196-198 Water Street.

Jeffrey M. Dumay, 31, with addresses in Somerville and Texas, was arrested at the 8 Sunset Drive location by Massachusetts State Police and Randolph Police. He was charged with the following offenses: Trafficking Cocaine weighting 200 grams or more; Distribution of cocaine; Possession with intent to distribute a Class B Substance (Xanax); Possession with intent to distribute a class C substance (Mushrooms); Conspiracy to violate the drug law.

Alex Brazier, 23, of 196 Water Street Fitchburg, was placed under arrest on an outstanding warrant and additionally charged with two counts of possessing a firearm without an FID card; one count of possessing a firearm with a defaced serial number; one count of illegal possession of ammunition; one count trafficking in cocaine; one count of trafficking in heroin; one count of possession with intent to distribute a class D drug. Brazier entered a plea of not guilty at his arraignment in Fitchburg District Court. He was ordered held pending \$50,000 cash bail.

Dumay entered a plea of not guilty at his Quincy District Court arraignment. A \$25,000 cash bail was imposed and he is due to return Jan. 19, 2021 for a probable cause hearing, according to Morrissey.

"The State Police Detectives from the District Attorney's Office had substantial ongoing partnership from multiple law enforcement agencies," District Attorney Morrissey said. "Detectives assigned to the State Police Detective Unit assigned to Worcester District Attorney Joseph Early's Office, the State Police Gang Unit and STOP team, Randolph Police, Weymouth Police, and the Fitchburg Police Department were all instrumental in this investigation, and the safe execution of these warrants."

"I extend my personal thanks to Chief Richard Fuller in Weymouth, Chief William Pace in Randolph, Fitchburg Chief Ernest Martineau, Attorney General Maura Healey, and District Attorney Early. Their cooperation and assistance resulted in the safe and successful activities this morning," District Attorney Morrissey said.

District Attorney Morrissey said the investigation is continuing.
